P E T I T I O N

COME Now the following actual residents and taxable inhabitants of Crouch, in Boise County, Idaho, and petitioning the Honorable Board of County Commissioners of Boise County, Idaho for the incorporation as a Village of Crouch, Idaho, do hereby represent, allege and petition as follows, to-wit:

I

That there are _____ taxable inhabitants who are actual residents of the territory hereinafter described.

II

That there are more than 125 taxable inhabitants and not more than 1000 taxable inhabitants in the territory hereinafter described.

III

That a majority of said taxable inhabitants and actual residents desire that the hereinafter described area be incorporated under the laws of the State of Idaho into a village, and that the same shall have all of the powers and authority, duties and responsibility of a municipal corporation, as set forth and provided under the laws of the State of Idaho.

IV

That these petitioners desire that the official name of said village shall be "The Village of Crouch."

V

That said village has not heretofore been incorporated under any law of the State of Idaho or otherwise.

VI

That a metes and bounds description of the proposed village and the territory embraced therein is as follows:

That an Order be made and entered by the Honorable Board of County Commissioners of Valley County so incorporating said Village.

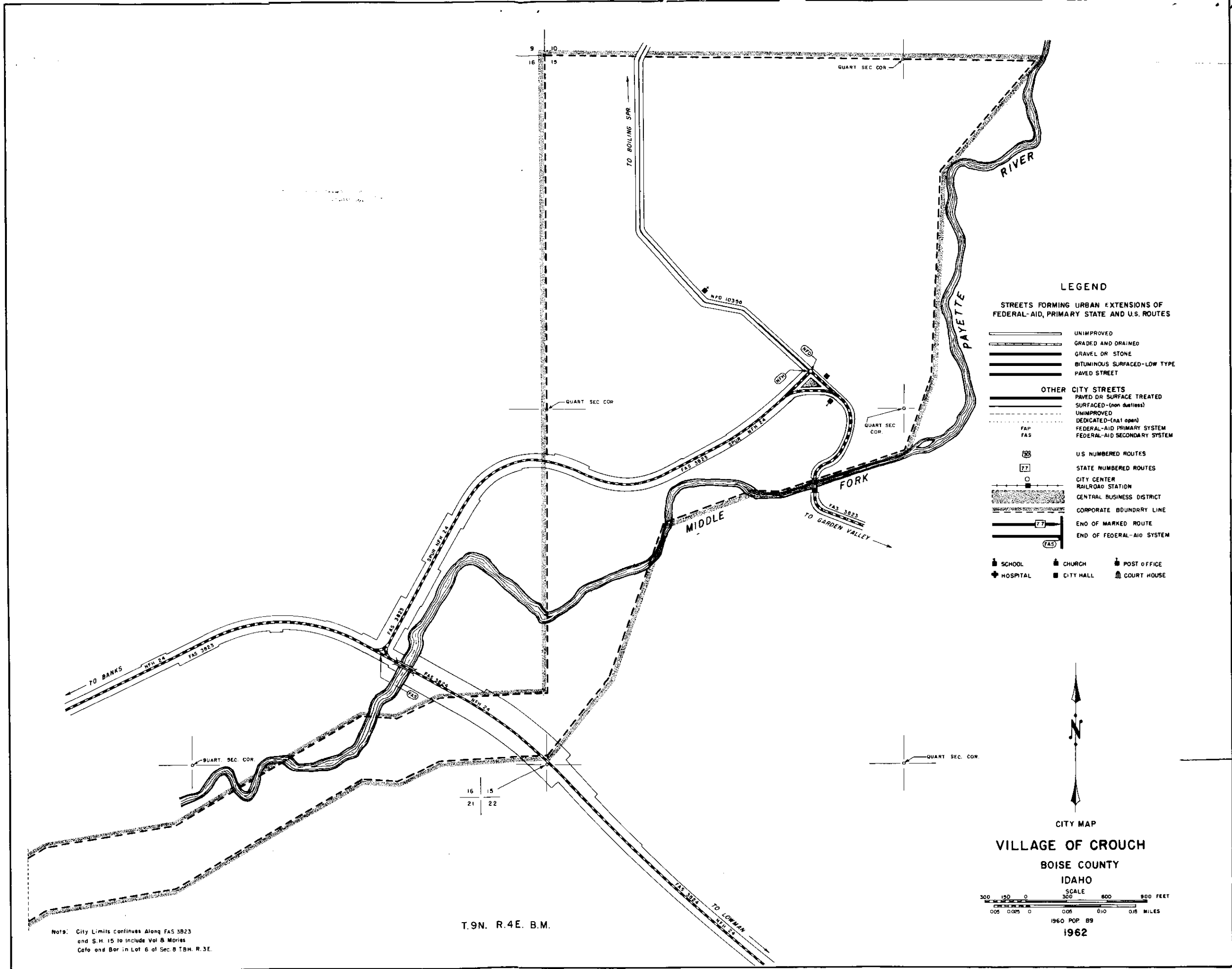
III

That upon the entering of the Order incorporating said Village, the said Honorable Board appoint five (5) persons who are qualified electors of the State of Idaho, who have been inhabitants of Crouch, and who shall have resided therein for three months next preceeding the entry of said Order, and that said five (5) persons be appointed to serve as trustees until the next General Village Election, as provided by the laws of the State of Idaho, to-wit: on the 4th Tuesday of April, 1953.
